VOLUNTARY REDUNDANCY: Several members have asked if they are still able to take voluntary redundancy. The answer is yes, as long as a suitable replacement can be found from either CTS or other colleagues currently at risk of redundancy. The substitutional severance process is described on intranet. We currently have a large number of members both at LHR and LGW who are trying to secure a roll, so please get in touch with one of your reps if you are considering taking VR.

PODIUM POSITIONS: A number of you have contacted us with issues when working on the podium desks, such as strains and backache. Your health and safety rep Jane Stevens is collating details of these incidents to take to the monthly health and safety meetings. Please report any issues that you have as we cannot take action without your feedback.

INDUSTRIAL RELATIONS STRUCTURE AT LGW: Most of the issues which you raise with your reps are discussed with management at the monthly Local TU Forum. Jasmine Dodd, Shirley Dugdale and Ian Cooper sit on this forum on behalf of the GMB. Where agreement cannot be reached at this level or if an issue needs to be resolved which affects all of the A Scales at LGW, the matter is referred to the A Scale Panel, Nick Hallett and Shirley Dugdale are your reps on this Panel and we meet monthly with the senior management team. We always use our best endeavours to reach an agreement, but on the rare occasion where we are unable to do so, we would refer the matter to the A Scales National Section Panel, which is made up of reps from A Scale areas across the airline and meets quarterly at LHR. Nick Hallett is your NSP rep for LGW. Please continue to bring any issues to our attention so we can use the meeting structure have to best represent you.

A Scale Pay 2013

Pay talks are still ongoing at the A Scale NSP. The company's current offer is an increase of 2% on basic pay with an additional 1% one off payment, which would be dependent on agreeing further efficiencies. We will keep you posted as the talks continue, and as always will consult you before reaching agreement.
