Pay Update

There has been no further progress on pay, and no meetings have taken place since we last updated you. An A Scale NSP is scheduled for 28th March, so we hope to be able to update you after this.

Engineering Update

Since we advised you of the company proposals for cost savings in engineering last month, little progress has been made. We will update our affected members in engineering via the local rep as soon as possible.

Outsourcing

On 6th March, the company advised the A Scale NSP that it intended to outsource certain functions within the finance department at Waterside, and they were already in talks with 2 suppliers. This could affect approximately 75 colleagues, in the A Scale and Banded communities, many of whom are GMB members. GMB are particularly concerned because in this case, the roles are likely to be outsourced overseas. We expect proper consultation to take place and alternatives sought before any of our members are made redundant.
